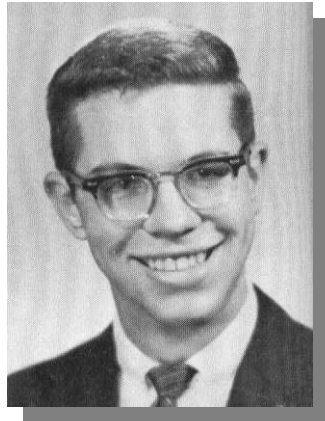

John Dahlfred, 66, of Londonderry, died Friday, Oct. 1, 2010 at Mass General Hospital in Boston.

He was born in Haverhill, NH on Sept. 15, 1944, a son of the late Vincent and Enid (Howard) Dahlfred, and had been a resident of Londonderry since 1983, formerly living in Connecticut. After graduating from Colby College in 1966, Mr. Dahlfred joined the U.S. Army and served in Vietnam. He was a current member of the Londonderry Historical Society and the Londonderry Heritage Commission.

He attended the Orchard Christian Fellowship Church. A self-employed antiques dealer, he enjoyed shopping for antiques, historical preservation and travel.

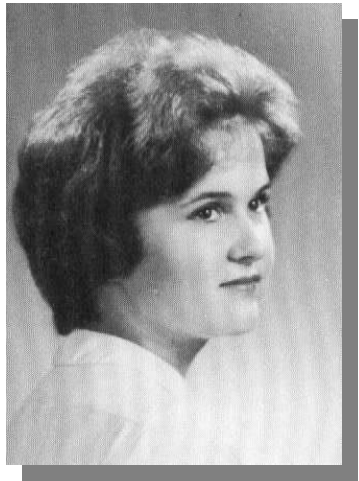

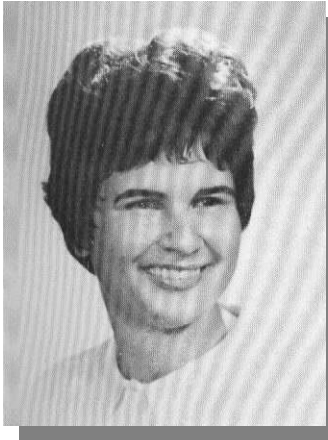

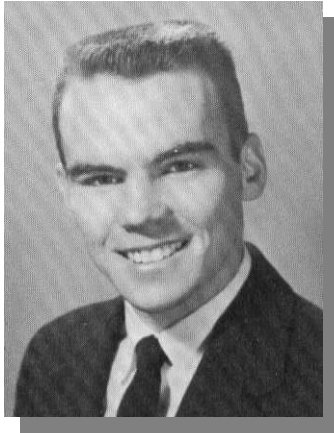
She also leaves behind a great many nieces, nephews, cousins and friends, including her special sidekick "Rascal", her kitty.

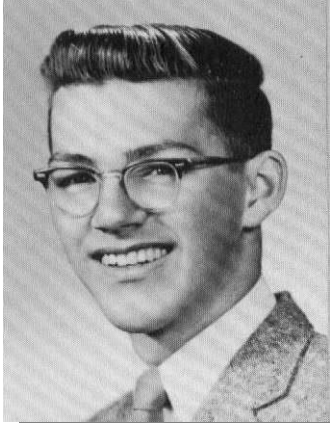

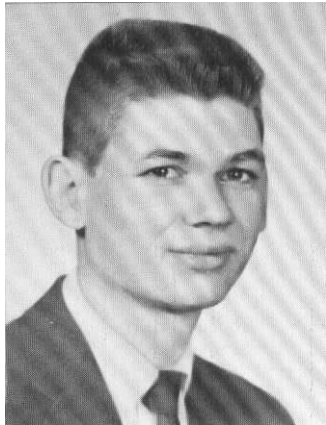
